Terms and conditions of Konopielka Bike Rental

- 1. These rules include the terms of use, conditions, rights and responsibilities of persons using the Konopielka Bike Rental, os. Debowe 4, 83-210 Zblewo.
- 2. The bicycle hire facility is open seven days a week, from 7 a.m. to 9 p.m. Bicycles are to be returned by 8 p.m. at the latest.
- 3. The bikes and accessories must be booked in advance by telephone or email (at least one day in advance in the case of daily bookings).
- 4. Renting a bicycle and signing the Bicycle Hire Register confirms that the Lessee has read and accepted these terms and conditions.
- 5. The rented bicycles are the property of Andrzej Majka i wspólnicy Spółka Jawna.
- 6. The rented bicycles are equipped with a safety cable with a key, front and rear position lights and a bell. Bicycle helmets are available on request.
- 7. The rented bicycles are technically sound and should be returned to the rental facility in the same condition.
- 8. The bicycle rental fee is collected in advance for the declared duration of use. If the bicycle is returned after the rental period has been paid for, a surcharge will be levied according to the valid price list of the rental facility.
- 9. An extension of the rental period shall be notified to the rental staff by telephone or e-mail. If after 24 hours from the declared return date the Lessee does not return the equipment or does not inform about the expected return date, it will be treated as a theft and will be reported to the Police.

10. The person renting a bicycle undertakes to:

- a. present an identity document with a photograph (identity card, passport or driving licence) from which the employee of the rental company will take down the data for the rental register,
- b. leave a pledge for the rented equipment at the rental facility in the form of an identity document or a returnable deposit of PLN 500,
- c. sign legibly in the bicycle rental register,
- d. be an adult and sober. A minor may only rent a bike with the consent of an adult authorised to take care of the minor, who takes full responsibility for the rented bike and the person using it,
- e. make the payment for the bike rental according to the valid price list. We round the time up to 0.5 hours in favour of the hirer,
- f. use the bike and its equipment in accordance with the intended use,
- g. return the bike to the place of renting: Gościniec Konopielka, os. Dębowe 4, 83-210 Zblewo, together with the equipment, technically fit, in an undamaged condition, within the time stated on the return date,
- h. use the bicycle only for non-commercial purposes and only for the borrower's personal use,
- i. respect the ban on lending the bicycle to third parties,
- j. do not use the bicycle for jumps, stunts, races, etc.
- k. always secure the bicycle against theft when leaving it outside the rental facility,
- I. immediately report any problems with the bike to a member of the rental staff and return the bike to the rental shop in the event of any damage to the bike during the ride,
- m. not to carry out any repairs, modifications or replacement of parts on the rented bike by yourself,

- n. pay for the costs of repairing the damaged bicycle or its equipment which are the fault of the renter,
- o. cover the costs for the purchase of a new bike in case of complete damage to the rented bike.
- 11.In case of loss of the rented bicycle or its equipment or accessories as a result of theft or loss, the Lessee is obliged to reimburse the equivalent of the costs corresponding to the value of the equipment, its equipment or accessories, according to the prices in force.
- 12.As a road user, the Lessee is obligated to obey the rules of the road and does so solely at their own risk.
- 13. The Lessee agrees to cover all damages and penalties related to the use of the bicycle resulting from non-observance of the legal regulations in force in Poland, including those resulting from the Traffic Code.
- 14. The Lessee waives any claims for accidents, damages or injuries occurring during the use of the rented equipment.
- 15. The employee of the rental company shall not be responsible for any accidents and damages, both to the Lessee and third parties, occurring during the use of the bicycle by the Lessee, provided that the accidents or damages are not caused by defects inherent in the rented bicycle.
- 16. The Lessee who damages or loses the bicycle shall be legally and materially liable.
- 17.In the event of damage to the bicycle a damage report shall be drawn up. The report of damage to the bike shall be filled in by a member of the rental staff with the person to whom the bike has been rented.
- 18. The rental employee has the right to refuse to rent a bike without giving a reason.
- 19. The Lessee agrees to the processing of his/her personal data by the Konopielka bicycle rental in accordance with relevant regulations, including in particular RODO and the rules of data processing stipulated therein.
- 20. Konopielka Bike Rental, as a controller of personal data, ensures transparency of data processing, in particular it always informs about data processing at the time of data collection, including the purpose and legal basis. The controller shall ensure that data are collected only to the extent necessary for the indicated purpose and processed only for the period of time necessary.
- 21. These Regulations shall be effective from 1 June 2023.
